- I agree to pay the designated vendor fee. (This will include an assigned 10x10 space and the distribution of promotional materials and information from my company in the monthly giveaway information bags.) All fees and paperwork must be received no later than one week prior to the event. There will be no refunds or forwards after reservations have been made and funds are accepted. (Returned check fees may apply.) Receipts available upon request.
- I agree not to exceed the 10x10 space allotted. (Exceeding this size tent would require a separate permit through the city and would have to be approved by Momma's Organic Market, LLC and be in compliance with Park West)
- I am required to provide my own 10x10 pop up tent and weights to ensure the tent is securely in place (stakes are not permitted since vendor spaces are on asphalt. We recommend sand bags.) I will also provide my own table(s), chairs, products, and business information. I agree that my tent is free of damages, rips or tears and looks presentable. Sidewalls or side cover shades on the tent are not permitted.
- I understand that access to electricity and water will not be provided.
- I understand that no open flames or flammable materials are permitted. (Ie: candles, deep fryers...etc.)
- I am required to obtain a City of Peoria business license (for information or licenses please visit [www.peoriaaz.gov](http://www.peoriaaz.gov)) and proof of business insurance. I will provide a copy of each to Momma's Organic Market.
- I understand that I am not to sell any drugs or drug related items, alcohol or any alcohol related products, obscene literature or merchandise, explosives, or weaponry of any kind.
- I will clean up all materials, trash, business information, etc...of any kind around my space and leave the area free of debris as I found it.
- I agree to comply with all laws and regulations required by Momma's Organic Market, LLC and the City of Peoria, AZ.

Reservations for vendor spaces are considered complete when all permits, payments and necessary documents are received by Momma's Organic Market, LLC and vendors may not set up until the above conditions are met.

I release Momma's Organic Market, LLC from any liability as a result of injury or damages caused or incurred to or by the undersigned, employee, company, or product present or sold at any Momma's Organic Market event. Momma's Organic Market, LLC is not responsible for lost, damaged or stolen items.

I understand and accept the requirements, rules, and regulations of vendor events in the city of Peoria, Arizona. I agree to provide copies of city license and proof of insurance to Momma's Organic Market, LLC.

Momma's Organic Market, LLC, must approve all vendors, products, and materials. Booth sharing must also be approved. Payment and all documents must be received no later than one week prior to the market date.
